That issue was tabled. Our current insurance co. is requesting an inspection by a Structural Engineer before we can renew our policy. The Board agreed to send the 2008 inspection we had done to see if the insurance co will except that. At the last board meeting it was voted unanimously to reclassify the liquor license from a Class D Public to a Class C which

is a club license. It would cost us \$500.00 less a year for the license, and \$210.00 less for the kitchen. The club license is \$20.00 a year to renew. All the liquor board needs is a list of the officers and a copy of the minutes. We will save money on our insurance policy do to less liability. We have been advised by our attorney David Mister to do this because now is the time to sell. There is talk in the political world that in 2017 the liquor license will have no value or less value than this year. As a club we can allow members and friends. Under 21will be allowed to stay in the clubhouse. They cannot sit at the bar and they have to stay on the other side. The only difference to the members is that we will not be able to sell carry out. Discussion took place. The Board is recommending to explore selling the liquor license. The Board feels that it is beneficial to the license from a Class D to a Class C.
