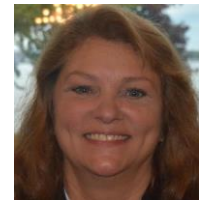

### BY-LAW Vote at this months Meeting

#### ARTICLE XIII (Voting and Quorum)

##### Old

Section 7

All members "in good standing" are eligible to vote on any matter. "In good standing" represents members that are current on all financial obligations.

##### New

Section 7

All members "in good standing" are eligible to vote on any matter. "In good standing" represents members that are current on all financial obligations *and have attended at least one membership meeting in the previous year.*

New (revised)

All members "in good standing" *and having attended at least one (1) membership meeting in the previous year are eligible to vote on any matter.*

"In good standing" represents members that are current on all financial obligations.

#### ARTICLE IV (Officers Duties)

##### Old

Section 7

RECORDING SECRETARY: It shall be the duty of the Recording Secretary to have the club seal in his/her possession or in the CLUB safe at all times; to maintain a true record of the proceedings of all meetings of the CLUB; to maintain a correct roster of all Members in numerical order; and to maintain all documents, records and reports connected with the CLUB.

**New**

Section 7

RECORDING SECRETARY: It shall be the duty of the Recording Secretary to have the club seal in his/her possession or in the CLUB safe at all times; to maintain a true record of the proceedings of all meetings of the CLUB; *to record attendance at all membership meetings for the purpose of establishing voting edibility*, to maintain a correct roster of all Members in numerical order; and to maintain all documents, records and reports connected with the CLUB.

ARTICLE XIII (Voting and Quorum)

**Old**

Section 4

Twenty percent (20%) of the members in good standing shall be sufficient to constitute a quorum to transact the business of the CLUB.7

**New**

Twenty percent (20%) of the members *eligible to vote* shall be sufficient to constitute a quorum to transact the business of the CLUB.7
