ARTICLE VII (Board of Governors)

Section 1

The Board of Governors shall consist of the Commodore and eight (8) elected members. Four (4) of the eight (8) elected members shall be elected annually for a term of two (2) years.6 The Commodore shall serve for one (1) year or until succeeded. Elections shall be held at the September membership meeting.
