New Members Welcome I'd like to start off by thanking the organizers of Red Eyes' Happy Hour on Friday, July 24th. It was nice to see so many members having a good time. It is a shame the weather was not as cooperative.

I'd also like to take this opportunity to congratulate Kitty Stone for taking and passing the course to get her Food Service Manager License. It will be so nice to have extra support for the Kitchen.

The Facilities Committee spear-headed by member John Gosnell have been busy working to get the WiFi working properly. Thank you for your hardwork and dedication to the project.

Now for the nagging part of my article. Well things don't seem to be going in the direction I would hope at this point. If everyone doesn't do their part, I believe the County Executive and the Governor may end up closing things down again. I've been monitoring things and wanted to make everyone aware of the newest set of guidelines.

- Anyone bartending behind the bar must wear a mask at all times.
- Anyone bartending needs to sanitize the area after each customer and at least the bartop, tabletops, and high tops every 2 hours.
- Bar stools should be distanced appropriately for social distancing and only 1 customer per bar stool. NO CONGREGATING AT THE BAR.
- A designated walk up service area is the end of the bar by the beer/wine cooler. 1 patron at a time to be served and everyone in line must distance themselves 6ft.
- Only 4 members per high top and 6 members to a table.
- Only 4 players to either the shuffleboard or pool table with no spectators gathered around.
- Masks must be worn at all times indoors except when seated at a bar stool, high top, or table with a drink in front of you. If you are moving about the building regardless of a drink in hand, you must have a mask on.
- Masks are required in outdoors spaces when social distancing cannot be upheld.
- Again, only 6 members to a table outside as well.
- Our capacity indoors is currently 45 members.
- The bar/Clubhouse needs to be cleaned/sanitized before any event/party/gathering and following an event/party/gathering.
- Effective August 1st, any rental will not have a choice to self-clean after their event and will be responsible for the \$120 cleaning fee because of the mandated Sanitizing before and after an event.
- The host of the event/party/gathering is responsible for policing their attendees and making sure everyone is in compliance of the guidelines.

We are expecting all members to comply with the regulations in order for us to stay open and operating. This is not

Notice for Licensees

Dear Retailer,

Over the past weekend, our inspectors were out in the County conducting random checks on establishments to monitor compliance with the social distancing and mask guidelines. While we have many establishments cooperating, we also found a number that are not. We want to thank those of you that are diligently complying with the regulations.

At establishments that were not in compliance, inspectors observed the following violations:

- Staff not wearing masks
- Allowing walk-up service at bars
- Lack of enforced social distance
- Bar stools situated less than six feet apart
- Patrons not wearing masks while not seated
- Establishments over capacity

We are serious about stopping the spread of COVID-19 and you have a responsibility to do your part. We will continue deploying our inspectors in the market randomly checking for compliance. Those found in violation will be issued a show cause notice by the Liquor Board and face potential indefinite closure by the Health Department.

By-Law Changes # 1

Article III

Section 1

OFFICERS: The officers of the CLUB shall be Commodore, Vice Commodore, Rear Commodore, Fleet Captain, Recording Secretary, Corresponding Secretary, and Treasurer. The Commodore, with the approval of the membership, may appoint other officers. The first four (4) officers shall be the Flag Officers. All officers, at the time of their election or appointment, and during their term of office, must be regular members of the CLUB in good standing.

Also at no time should a candidate for Commodore, Vice Commodore or Rear Commodore be placed in office without holding on elective position in the past.

ARTICLE XVI (Resignations)

Section 1

Resignations shall be sent, in writing, to the Corresponding Secretary. Until a written resignation is received, all obligations to the CLUB shall be in force. All letters of resignation shall be presented to the members for

approval at the next regular membership meeting. At that time, if approved, the resignation shall be retroactive to the day and hour of receipt and the person shall be so notified.

ARTICLE XVI (Resignations)

Section 1

Resignations shall be sent, in writing, to the Corresponding Secretary. Until a written resignation is received, all obligations to the CLUB shall be in force. All letters of resignation shall be presented to the members for information at the next regular membership meeting. The resignation shall be effective the day and hour of receipt and the person shall be so notified.

(Clarification /change): Members cannot keep another member from resigning.

- 1. Fix the broken hose bib under deck
- 2. Wipe down all the tables and chairs with cleaner (Weekly)
- 3. Sweep and mop all floors (Weekly)
- 4. Clear dust away from all vents on the coolers, fridges, and freezer (Monthly)
- 5. Dust and wipe down all bar bottles and bar area (Weekly)
- 6. Clean all windows, inside and out (Monthly)
- 7. Clean and stock men's room and ladies room (Weekly)
- 8. Trim branches over-top dinghy rack and cooler room.
- 9. Clean leaves from gutters.
- 10. Check straps on a/c units for dry rot.
- 11. Weld railing spindles in place around deck.
- 12. Re-attach outdoor speaker near men's room.
- 13. Tighten bolts on both men's commodes to help with rocking.
- 14. Hang fire extinguisher box on wall at top of stairwell.
- 15. Re-attach towel dispenser in downstairs ladies room.
- 16. Replace switch plates in men's room.
- 17. Prior to and after VYCA meeting, our General Membership, and other events.

- 1. Clean and mop the clubhouse.
- 2. Take out all trash including bathrooms and bar area.
- 3. Restock bathrooms.
- 4. Wipe down bar area and bottles.
- 5. Restock coolers and sodas.
